MyPayments Plus opens up July 10th for current UA Families to complete the following: #1 The Field Trip Permission Form - due no later than August 9th. This online form gives your child permission to participate in on & off campus field trips and community service. This permission covers the entire school year. This form does NOT register you for any trip. Registration for field and overnight trips must be done separately in MPP. Check your child's MPP dashboard weekly to see what trips, activities and more are available. Field Trips info can be found on your school's page, Lower, Intermediate, Middle & High. The permission item includes a digital Mandatory Medical Information Form. #2 Yearly Dues - due no later than August 26th. Annual dues are expected to be paid at the beginning of the year and cover the Family Day shirt, all on-campus activities, the End of Year Party, School-wide Service Projects, and more. This form covers all on-campus experiences. Off-campus trips must be paid for separately. Yearly Dues cost and breakdown information can be found here. If dues are not paid by August 26, you child will not receive their family day shirt on time. Parents who do not pay the activity dues are not eligible to chaperone field trips. Legislative History President Bush Signs Genetic Information Nondiscrimination Act of 2008 Washington, Wed., May 21 2008 — The President has signed into law the Genetic Information Nondiscrimination Act (GINA) that will protect Americans against discrimination based on their genetic information when it comes to health insurance and employment. The bill had passed the Senate unanimously and the House by a vote of 414 to 1. The long-awaited measure, which has been debated in Congress for 13 years, will pave the way for people to take full advantage of the promise of personalized medicine without fear of discrimination.
