Reasonable suspicion testing is performed when there is evidence or reasonable cause to suspect an employee of drug use. Such evidence is based on direct observation, either by a supervisor or another employee. Reasons to conduct a reasonable suspicion test include: Physical signs - Bloodshot eyes/dilated pupils, slurred speech, unsteady walk, shakes or tremors, unexplained sweating or shivering, fidgeting/inability to sit still, sleeping at work, or difficulty staying awakeBehavioral signs - Attendance problems/tardiness, a pattern of absences or excessive absenteeism, a decline in performance/productivity, acting withdrawn from othersPsychological signs - Unexplained changes in personality or attitude, sudden mood changes, angry outbursts or inappropriate laughing, inability to focus or concentrate
